[REDACTED], I inform you that I have filed a complaint recommended letter to Mr. Prosecutor of the Republic of Paris, Mr Rémy HEITZ September 11, 2019, against Mr. Jean Luc Brunel, Ms. Ghislaine Maxwell, Le Prince Andrew, complicity and in light of the death last August of Fe Jeffrey Epstein, the legal proceedings were extinguished in France, and then I have again filed a complaint in the offices of the [REDACTED]

[REDACTED] on 17 September 2019.

This interview lasted two and a half hours and I was unable to develop the rest of the my grievances to this network.

According to the French Judicial Police, Mrs Lantin my complaint would be prescribed and that his service would not interrogate my paternal family, I inform you to be October 26, 1980 and I have, under the new terms of 2018, the application of the extension of the statute of limitations to thirty years after the for the majority of sexual crimes against minors.

This provision applies to all victims born after 6 August 1980 who were not yet 38 years old on 6 August 2018, the day after the law was published in the Official diary. The law came into force after the publication in the Official Journal in 2018.

Therefore, I inform you that my complaint cannot be struck by the statute of limitations on violent rape in France, repeated confinement (cellar, room, massage room, planes, car with driver), violence with weapon and physical, harassment aimed at discrediting my words and my person, deprivation water and food, verbal threat and intervention in my jobs, administration of a substance without my knowledge, in a glass of alcohol on [REDACTED] and then rape on a couch on the same evening around [REDACTED], [REDACTED]  
[REDACTED] in order to alter my discernment or control of my actions, abductions (and repeated in France) on my little person, without the parent

If so, there will have to be a French-English **translator** and have me sign the declarations in French. I'll do them. thank you for **interviewing** the people named in this letter and for obtaining a international arrest **warrant**.

I'm sorry about the **length** of my mail, but it's important that you understand the **whole** situation as a whole, it will be up to you to recover this which is important to **the** investigation.

I would like to know **if** the French and external victims in the United States can integrate the **Us. civil** proceedings? If so, I ask for your benevolence to analyze my **requests** and integrate me into them.

Thank you for asking **the** various victims, if they so that I can trace **my** entire history, with the good dates, places, **all facts**, adult people present etc.

I would like my **childhood** photos to be compared to videos of rape children you would **have** recovered on the island of Saint James in 2008. To that end, I gave a USB stick to **the** [REDACTED] police to make comparisons. I am passed by Little **Saint James**, this island was not yet to belong to him, a Muslim-born **military** found me confined to a room, he tried to but I didn't **understand** his language, frightened I backed off being very frightened, not fed, not washed, **in** sexualized dress type sado-masochist (leather) that left

glimpse of my child's **body**, and then I saw a man in a white tunic similar to the Saudi men with little **whiskers**, who looked at me near the door, he looked at me sadly **and I** was doubly, The Military and Jeffrey Epstein spoke virulently outwards, he again tried to talk to me indicating the word "**rape**" I understood "rapt" as the verb rapter. I couldn't acquiesce or respond to this soldier in uniform. Shortly before, Jeffrey Epstein told me in a single word "**shark**" in French indicating the range of his arm, I do not understood nothing, **moreover**, he often spoke to me in his native language and sometimes

incorporated a single word in French, it seemed crazy to me. He could see that I didn't understand not his tongue and it seemed to amuse him.

I would like to know whether Mrs Marlene SCHIAPPA Secretary of State to the French Prime Minister to the right, as the case stands, to ask for the requisition, hastily made to Mr. Le Préfet de Paris, of the property [REDACTED]  
[REDACTED] in Paris who is owned by the Trust?

Indeed, I would like to ask you about the possibility, to freeze Fe Jeffrey EPSTEIN's assets in order to avoid further covetousness and concussion phenomena linked to recurrent abuses of power, and which put in place additional difficulties in the demands made by American victims.

Provisional freeze on Trust assets would no longer commission cash people who act in society, whether political or simple.

Fellows. This would stop the intimidation and limit the information it Seek.

If, however, political figures, lawyers and other members of the French bourgeoisie would oppose the demands I make in this present I thank you for informing me, in order to remain transparent and allow me to act accordingly.

I was raped in this apartment, like a disjointed puppet and the fact that she can imagine, that victims can rebuild themselves in this place has strongly shocked, my back gave way, I sleep very badly, I have a lot of emotion to writing this letter, I have intense psychological fatigue and I preferred to put him on sick leave.

I have never received any help, or very little.

France has not made the choice to lift the statute of limitations for crimes committed on French soil and as Ms. SCHIAPPA writes in her official letter October 16, 2019, she believes that Mr EPSTEIN did not rape a child in France, only in the United States and denies the truth of children sold by their families in France.

Her approach hinders the investigation and may prevent further complaints from arriving, Ms. SCHIAPPA prejudges the purpose of this case and multiplies the difficulties. In its functions, it has a duty of probity and non-concussion.

[REDACTED]. The French investigation has just started and is not Judged! Political pressure has no place on the EPSTIEN dossier and complicity and may interfere with the consideration of our complaint sets present and future as yet unknown.

I would also like to thank you for hearing from the American victims, in a session after the death of the lead author, they spoke for us as well. We must continue the fight.

In addition, the declassification of part of the file allowed me to understand a hidden part of my past and my deep evil being, I spent six years crying from ██████████ every day, without knowing why. This declassification allow us to live with less impediments to our individual freedoms and our freedom of action, including judicial action, as well as to protect us personalities close to this network. They're out in the open. This spark of truth carries me and, gives me back faith and hope.

I would like, if my French complaint is accepted, to be able to make a re-enactment at the site, which is essential to my recognition and personal reconstruction.

I inform you that my testimony on honour, can be produced by lawyers for civil parties and integrate different cases of victims of the network EPSTEIN.

I speak today, I take this risk to defend the child I was, and who died with repeated rapes I'm talking about today because child crime must stop, I speak today, because mothers are unfanted and young children harassed by unhealthy and conscious adults of the harm they do, harassment that is very hard to prove, mothers who are going to lose everything, who will not see their children grow up, who cannot answer for education and the affection they sincerely wish to give to their children, I speak today, because we were forced to pay 13 years of litigation fees that did not gave nothing, and that made us poor, despite the efforts and work, week after week, which my mother carried out without ever complaining, without being able to make projects for the future, I'm talking about today, because they sought to achieve my autonomy social, financial, but also the love I had for myself, and that I had with my mother, this violent separation was voluntary, in order to subject me to trafficking and

sexual slavery in France but also on your soil. Yes I speak because I didn't have to live in so much **perversion**, year after year, nor to see the French institution be used against the **targeted** victims of this network. I've never participated in what **this** network was asking for and I am proud to be who I am, despite that they destroyed **me** and the grave projective humiliations done to me, in every phase of my life **and** my development.

Don't deprive me of **this** fight. My power is speech.

I had no ambition to **be** the scapegoat, nor a pain sufferer a deviapist, criminal **and** dysfunctional family and then society.

I tell you that only my mother's unfailing love kept me alive, and I would like her to be recognized as a caring parent, I ask justice and truth for her as well. She is a collateral victim of this organism materialandophobic and criminal.

That is why, I thank you for accepting the recording of my civil complaint in this case of international human trafficking, and to bring me your help and protection.

In your opinion, would this human trafficking not be a crime against humanity? The tally is quite substantial, which would allow the prescription in all countries and get the whole truth, and release hundreds homes and children they are relentlessly looking for. It's not because J.Epstein is dead that this network is destroyed.

My position is really very uncomfortable, there is a surreal side, I do didn't think i'd ever have to write to the U.S. Secretary of Justice and the FBI! In explaining facts that shake every part of my body and mind, when I write them, which go through paternal family ties, ties that are have been non-existent for several years.

However, I am very honored to tell you my certainly cruel story, but which will hopefully contribute to the emanation of the truth and the condemnation of authors of this organized network. I don't know your future decision as to my requests, but I wanted to thank you sincerely for your stated will, which gives me the energy to write to you, I also thank you for declassifying a part of the case, otherwise I will still ignore some of the facts that have come up with the photos and articles in the American press as early as August 2019, I had only pieces of disparate memories that did not connect together. And I say a great thank you to the FBI for the long work they have done, to which I testify my deep respect and my total gratitude.

This network has never given us a choice, nor in the face of the various violence torture, or in relation to the legal proceedings, we are at the

new constraints and **justice** in the grip.

Besides, I didn't know **the** names of the perpetrators of my rapes. I didn't deserve not to experience **such** relentless violence, I have never done anything wrong, I don't drink alcohol **or** little, I don't do drugs, I've never been condemned by Justice, I was just a **child** who played in a garden and asked nothing of person, I was full of **love** and eager to be loved, I was denied and destroyed by the worst on earth, today I am robbed of my voice, and I am given back Invisible.

What courage can he have to attack young children and then our lives, what jealousy and hatred are they animated to decide that their money can take the purity of a child and vilify families, who are they?

France knew, France has been silent, so far I ask it to act with dignity and honesty, by lifting the rape statute of limitations of this network international and criminal, this case is exceptional.

I strongly advise French lawyers on the victims, who are in associations that help victims and who speak out on programmes or are questioned by the French press, to avoid talking about prescriptions when they about the other victims, they have the right to defend their own clients but in intrude on the legal process of other cases.

I recognized a young American woman in the victims who denounce and who said she participated, she approached me in the streets of [REDACTED] around [REDACTED] I'm going to do it. thank you for explaining the situation and enlightening us on the requests made Epstein at the time of the incident.

Thank you for telling me how to find a lawyer so that I can defend my interests, to inform myself about this matter, requests I can make to you.

There will probably be other memories that will come back, cepedinating in immediately, a summary of the facts.

I left documents at the [REDACTED] Police Department that you can retrieve where that I can send you, secondly.

I ask to know the whole truth and under no circumstances, compensation "of a newly formed philanthropic fund," nothing will make me omerta. All the money from Jeffrey Epstein's Trust comes from human trafficking, organized gang blackmail.

Thank you for keeping me informed, for keeping at my disposal all physical evidence of the recordings and photos that were taken, I leave you my email address and acknowledge receipt of this recommended mail.

I didn't think it would be so hard to tell truths in this world,

Incestuous fathers know how to play with the dysfunction of institutions and play on the child's fears of living with strangers.

Child criminal families know how to make their child object vulnerable, preventing him from achieving his autonomy, by removing the caring parent and can to make them available to others, they also know how to compromise and get the omerta.

"The reversal of the charges is a well-established perverse tactic: vampire's signature. The 'virtuous incestuous father', an honorary member of a association of angry fathers, systematically defers the responsibility of his criminal act on his victim, allegedly vicious, seductive, perverse "polymorphic" or by denouncing the attitude of his victim, or the consumption alcohol, work, fatigue."

This makes it possible to measure that social reasoning only works by admitting to what we are trying to show (the purpose -the culture of rape as structuring social order). We must accept the truth and end it!

Rape, child crime, sexual assault is the primal training tool exploitation and domination of gender and class.

Some people who seem to be advocating for human rights may sometimes support ingedming paedophile and pro-rape ideologies, under the guise of fighting for human rights women's rights and the rights to health and well-being, or

freedom of expression, philanthropy. The philosopher and psychologist demonstrates, in line with his in-depth work on the psychology of power of the grip, we can decipher the perverse mechanisms that contribute to the implementation work of this system through the sexual transgression of children and teenagers, or self-projections that one would like to get rid of on ("It was the child who lured me!"), which is a denial of the truth/reality. They impose their delirium, on the basis of a delusional contagion that he it's about identifying to protect yourself from it. They destroy children and persecute

who do not condone or turn a blind eye to transgressions paedophiles of 'intellectuals', 'artists', 'filmmakers', 'pseudo-scientists' and "psychoanalysts" - "TV animators" etc., who are very good speakers, know attract and profit from protective sympathizers, and know how to galvanize crowds in France.

This is a reasoning that is very difficult to counter, pro-paedophiles and anti-rape stakes challenging all the arguments by brandishing the deleterious responsibility of social morality opposed to the liberalisation of sexuality with adolescent children, but also by investing in the field of neuroscience, law and anything that can be hijacked. This pro-pedophilia speech has cost the lives of many adults, former children who are sexual 'partners' of paedophiles and who have not endured the depersonalizing and dehumanizing experience of being a sexual object. It must be very clear about this: neither in France nor anywhere else, I have never read, never heard, never met anyone who could testify that the sexuality he had lived as a child was without adverse consequences on his adult life. Libraries are full of testimonies going in the radically opposite direction, and none of his testimonies of former victims do not suggest identification with its predator children who grew up in the 1970s in social settings libertarians and intellectually in favour of paedophilia bear witness to the horror to be an adult's sexual 'partner'. Pro-paedophiles are bad faith and lie pathologically; you have to keep that in mind.

Despite the death of the main accused, we will suffer his pollution, victim-blaming at a international scale and we will have to live with this history and its polytraumas to our last breaths on this earth. Denial and memory protected me until [REDACTED], during the first flashbacks, they protected me kept alive, this survival mechanism has been a lifeline for dashed life.

The consequences are very serious, they disturbed my child psychology, maybe even my DNA and fortunately I didn't become like them.

I was put to death from childhood, and I must remain in the omerta and die slowly

fire so as not to disturb French society, which does not want to evolve in the field of rape of a minor.

I couldn't have a dream, and building my life, I couldn't connect with my emotions and to my true story, they abused us in every way.

I no longer want to live in a country that does not defend its innocent children, nor even give birth to children in France. And thank you for granting me your protection and/or I allow myself to apply for political asylum momentarily, until the end of the trials, I will not find any work in France, there might have job I could have in the U.S. and learn your language and your culture, I do not feel safe in France, I asked the Police if I could have police protection and they don't give me any New. They do not provide more psychological emergency assistance, no protection

police officers at the risk of being in danger of death.

When you hear about 2X7, it can also be a program/cycle done to the child with methodical states of abuse, 7 to 14 years old, because predators have specific demands and especially sadistic and preferably ages, in my case [REDACTED]



I remember being crushed by its weight, I could not breathe, on a big white bed, and filmed. Then it was really very mean, in my thought as a young child that's what I thought. "It is wicked sir there! ».

I went to all the properties of EPSTEIN (new Mexico, islands probably little Saint James, without it being the owner or had just been; a skyscraper considering the elevator floors probably in New York or Washington windows were obscured by black fabrics: place of orgies children-adults etc. ;

- there were sexual orgies with minors. The pimp wanted me to look, he wanted me to go, I refused to look sickened and go, then I was grabbed by people, on leaving, I urinated down in the hall and I shouted that I had been raped in French, to the guard of this tower, there were screen, I was dressed in sexualized clothing in leather strap, which let my body appear. I was raped in the elevator also by the (who was to work for Brunel Jean Luc), the little girl to the parents disabled people was also present. This pimp had asked the little girl to sexually touching me, which she did. I urinated and shouted that I had was raped in the Hall and the guard came up to us. There were at least three Elevators.

- and in a house with a floor with white blackout shutters, at the level of the
